The Chair informed the committee that at the time of this convention meeting there are still States that have not submitted reports. She further stated that there is no consequence for said action. Discussion ensued. A motion by Marilyn Madigan, NB, and second by Patricia O'Connell, NB, that fines for non-compliance should be the same as the fines for the annual reports. The Division level fine of \$25.00 for first 7 days and then the second 7 days \$25.00 more and then suspension. County level (if applicable) fine of \$50.00 for first 7 days and second 7 days \$50.00 more and then suspension of County. The State Board will be accessed \$100.00 for the initial 7 days and then second 7 days \$100.00 more with suspension of all activities of State Board for non-compliance. Motion carried.
