

Site visits for the 2025 NYS Men's and Ladies Convention wrapped up in February. It was not an easy decision, but we selected the Woodcliff Resort and Spa in Rochester, NY for the site of the 2025 NYS Convention. I would like to thank all the Divisions that made presentations and hosted us in their areas. The committee will be working on prices, packages etc. and we will publish them as soon as they are finalized. The negotiated price will be valid July 15th – July 20th. The dates for the Convention will be July 17th – July 19th (Thursday – Saturday).

It is very important that everyone has read the proposed National Constitution changes. Please remember that these are proposed changes and as such, you will all have the opportunity to vote for/against any of the proposed changes. National President Madigan has announced that Zoom meetings will take place to discuss and vote on the changes in the weeks leading up to Convention. She is also allowing all members in good standing to participate and vote in these Zoom meetings. Only motions that receive a 51% favorable response on the Zoom call will move forward to the Convention floor. At Convention, only Delegates (or Alternate Delegates) will have a vote. A motion will pass with a two-thirds (67%) majority on the Convention floor.

The National Convention will be held in Orlando, Florida August 7th thru August 11th. Please visit the Convention website www.orlandoirish2024.com for details. If you are attending the National Convention, please book your room before June 15th using code GRPAOHAUG2024 to receive the negotiated Convention rate. The website also has the rates for the dinner packages.

Thank you for the submissions for Lifetime Membership. The Board will vote at our meeting on April 30th. We had 6 submissions. National has asked for only 1 per State; we are such a big State we will be sending more than 1.

Project Children will be celebrating their 50th Anniversary in 2025. One of our members from Westchester County, Noreen Ryan, is an Ambassador for Project Children and will speak to us at our meeting on May 4th. While young children are no longer coming to the United States for the summer, Project Children is still a vibrant organization sponsoring young adults from Ireland and Northern Ireland giving them the opportunity to take part in an internship program here in the US. As Project Children celebrates their 50th Anniversary, Noreen will share with us the

plans underway to move the archives of Project Children to the Monahan Peace Campus in County Monahan.

Thank you to all who completed their year end reports on time. There were a few bumps along the way with both the Treasurer and Secretary reports, but that's all behind us now. Thanks for your dedication in completing these reports accurately and timely.

On April 7th I attended the dedication of the Tom Clarke and Kathleen Daly Clarke monument in Suffolk County. After the service, Fr. Henry said Mass at Suffolk County's Mass Rock, followed by breakfast at a local restaurant. While I did know a few familiar Sisters, it was very nice to meet others who I did not know.

On March 1st, I attended the Irish Unity Summit at Cooper Union in Manhattan. There were several LAOH and AOH members there from NY as well as across the country. This unity summit was sponsored by seven Irish American Groups, one of which is The Ladies Ancient Order of Hibernians. Our National President was a speaker at the summit. Mary Lou McDonald, President of Sinn Fein was the keynote speaker. The underlying theme throughout the summit was that all over Ireland conversations about Irish Unity are taking place. From community centers to college campuses, it is clear that the question of Unity is no longer one of 'if' but is now one of 'when'.

The marching season this year was spectacular. The 3 parades I marched in had beautiful weather and I enjoyed great Irish camaraderie following each parade. I marched in Mineola, NYC and Pearl River. Thank you Joan (Moore) for the invitation to march in the Pearl River parade.

Report of the Office of the Secretary

Dear Sisters, Spring has arrived at my home County of Kings. The trees and plants are starting to bloom with beautiful flowers. I am happy to say goodbye to the cold weather until next year. The following is my Secretary's Report.

Annual (Year-End Reports): I would like to thank all the County and Division (Recording and Financial Secretaries) for submitting their 2023 Membership Reports and for working together in preparing these annual reports. I reviewed all the reports and forwarded them to LAOH National Secretary, Sandi Swift, before our March 31, 2024, deadline. (LAOH NYS for the year 2023 had a total of 3,469 Total Members, and 3,423 *Taxable Members). (*Note: Per Capita Tax and Assessments are not paid on National Life Members and Members who are listed as Religious on the Membership Reports).

25 or 50 Year Membership Certificates: I will be distributing Certificates at our General Membership Meeting on May 4, 2024. Congratulations to all the ladies who have achieved 25 or 50 Years as a LAOH NYS member.

Changes in Member Information: If a LAOH member makes any changes that may affect the Secretary's Master List (database), I ask for the County or Division Secretary to email me the changes, asap. (ex: name, address, phone, email, transfer out of *or* into another Division, etc.). In addition, if any County or Division has Elections, I ask that the Secretary send me the new information on the Officers/Appointees including their personal information and their 'new' Title.

Closing (Disbandment) of a Division: I am enclosing information on proper procedures for Disbandment of a Division as written in our LAOH Constitution. If a Division is planning to close, it is important to complete all procedures (see below) no later than June 30th of that year, or the Division will have to pay Per Capita Taxes for their members (excluding National Life Members and Members listed as Religious on their annual report). If you need any assistance, you can email me or contact LAOH NYS President, Regina Begley at nyslaohpresident@gmail.com .

ARTICLE VIII DISBANDMENT OF DIVISION

Section 1. When a motion is made to disband a Division, a special mailing by the United States Postal Service (USPS) must be sent to all members in good standing, as well as the National President, State Board President and County Board President, advising that the motion to disband will be discussed and voted upon at the next regularly scheduled meeting.

Section 2. Upon passing of the motion to disband, all members, as well as the National Board President, State Board President, and County Board President, shall be notified in writing that the motion has been passed.

Section 3. The notice of disbandment shall include instructions on how to pursue transfer to another Division. All transfers shall be completed within this ninety (90) day period.

Section 4. When a Division disbands, all property and funds shall be forwarded to the State Board Secretary or National Board Secretary. If this Division is part of a County Board consisting of three or more Division, all property, funds, books, and records will be forwarded to the County Board Secretary. The Charter is to be returned to the National Board Secretary. The Division President is required to advise the National Board President, Secretary and Treasurer and State Board President, Secretary and Treasurer; and County Board President, Secretary, and Treasurer that the Division has ceased to operate; that the bank account has been closed; and that the properties have been transferred. If this Division was a part of a County Board consisting of only two Divisions (itself and one other Division) the County Board ceases to exist within ninety (90) days.

Section 5. Before funds are disbursed, all per capita taxes, county assessments, and state assessments must be paid if the Division existed for 6 months in that year.

In closing, I am looking forward to seeing everyone at our LAOH NYS Spring State Board Meeting, Saturday, May 4, 2024, 10:00 AM, at Gavins Irish Country Inn, Cornwallville, NY.

Happy Spring! Hope this report finds you well and recovered from the busy month of March parades and dances celebrating with pride our Irish Heritage, Catholic Faith, and Women's History!

As your Catholic Action Officer, I would like to thank you for all the hard work you do in raising funds to support Project St. Patrick and SOAR! so generously! There were 32 PSP grants awarded. The 2023 Y/E Donation Report lists NYS PSP donations as \$5,150; SOAR! \$2,750; Missionary Sisters of the Holy Rosary \$1,450 and National Humanitarian Fund \$5,000, for a total of \$14,350. Wow! This is the accounting that I have received from our National Catholic Action Officer; a copy of the Y/E summary and report for NY (sorted by County) are attached to this report. I expect an accounting of the 1st Quarter donations for 2024 soon and will share them when received.

The email from the National Catholic Action Officer Kathleen Diulus containing the link to the 2023 Catholic Action Report (to be completed by the 2023 County/Division CA officers) was forwarded by this office to the County/Division Presidents and Catholic Action Officers on February 3. As of March 30, approximately 25% of the reports were received from NYS. All Counties/Divisions should complete their report by June 30. Please let me know if you have any questions. A Zoom meeting was hosted by the National CA Officer on February 10 to discuss the report and to answer any questions related to Catholic Action. I hope you all had a blessed and Happy Easter. Spring is right around the corner but enough of April Showers LOL! I wish to thank all of you who sent messages of sympathy on the loss of my sister and of Dermot's Brother. Your kind words helped us through this difficult time. Since the Legacy Bill passed there had been increased pressure on the Irish Government to file with the European Convention on Human Rights to protest this Bill, which they finally did. With just over a month to go before the British take away the rights to inquests and ombudsman reports from victims' relatives, the United Nations Committee on Human Rights called on the British to scrap or amend the bill. On April 16, 2024, Andree Murphy, Deputy Director of Relatives for Justice, will fly to New York to speak on behalf of Ireland's Future to the event sponsored by Comptroller Thomas DiNapoli's "For a Commemoration of the Good Friday Agreement". She will speak on behalf of Ireland's Future about the importance of a poll which would allow Irish reunification. We are also hoping, that with two weeks to go before the British take away the rights to inquests and ombudsman reports from victims' relatives (May 1), she will also get a chance to update us on the British legacy act. The Legacy Justice bill passed in September makes the impact on the groups programs we support through our FFAI Christmas fund even greater. The strain on mental health services, legal and justice groups and community support programs has increased because of this shameful legislation aimed at stopping the truth from coming out about collusion. With our donations, we are providing justice groups with the support they need to take steps to have this legislation scrapped. Our contribution to community groups will help bring hope to underfunded areas through sports and mental health programs. Collectively these programs work to provide for a successful future that will inevitably result in the truth coming out and a United Ireland. The Appeal was closed as of March 1, 2024, for last year's Appeal but we are accepting donations all year long and they will be applied to the 2024-2025 Appeal. As always, the ladies of New York have been generous in their donations, and I hope to have the NY Breakdown at the May 4th State Board Meeting. Be sure to check our NYS Facebook page as well the National Freedom for All Ireland Facebook page to learn more about what is going on in Ireland and the important role America has and continues to play in the continued effort for a United Ireland. Thank you all once again for your support. I look forward to seeing many of you in East Durham. Stay safe.

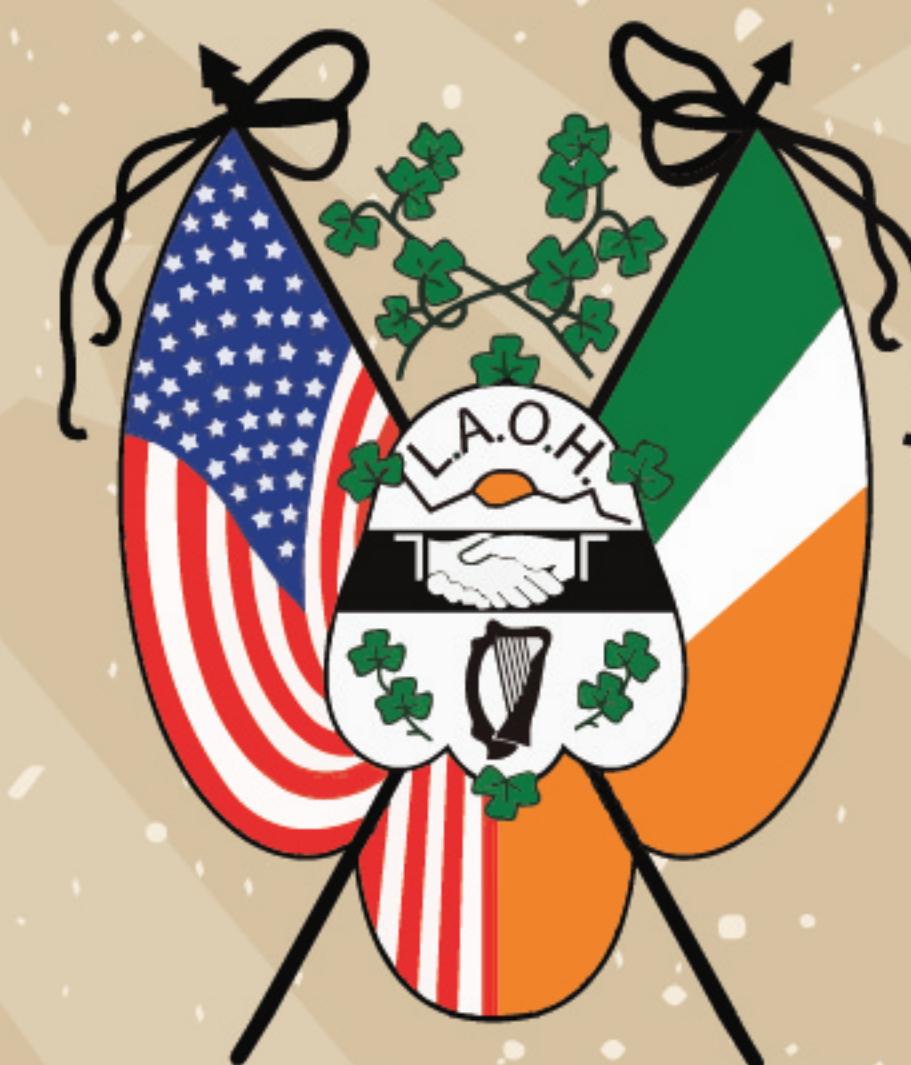

Dear Sisters,

Immigration, prior to the 1890's, was regulated by the individual states, rather than the Federal Government. New York has approximately 8 million immigrants pass through Castle Garden, from 1955 to 1990. (Castle Garden is now known as Castle Clinton. It is located in Battery Park in lower Manhattan.) Ellis Island was opened in 1890. Many of you know that Annie Moore from Ireland was the first immigrant to be processed through Ellis Island. If you have listened to the song "Isle of Hope, Isle of Tears", please do so.

The Ellis Island website has a feature where you can check the passenger records of some 65 million people. The Ellis Island Museum will be getting a \$100 million facelift.

According to the Irish Times, a major exhibition is being launched in Dublin on the history of the Irish in Britain. The exhibition at EPIC, the Irish Emigration Museum tells the stories of many of those who left Ireland for Britain from the early seventies onwards, often suffering from discrimination provoked by IRA attacks in Britain.

Last week, Oklahoma House Bill 4156 cleared the first hurdle. The Bill would create a new crime in Oklahoma called "impermissible occupation," which is aimed at addressing increased illegal immigration into the state. It has to go before the State Senate for a vote.
